Functions:

The Greene County Sheriff's Office is the primary law enforcement agency servicing roughly 19,000 people within 157 square miles, and is located just north of Charlottesville, Virginia. It is comprised of dedicated individuals sharing the vision of the Sheriff, and who perform as a team to accomplish set goals and objectives.

Sheriff Steven S. Smith's **Administration Division** is directed by Major Charles Swingler, and consists of an administrative assistant and two clerical support staff.

Both the **Field Operations Division and Criminal Investigations Division**, is lead by Captain David Roach. On the FOD side he oversees patrol, court security, civil process, school resource officers, K-9 and animal control functions. Field units have the primary tasks of answering calls for service, investigating minor crimes, serving civil process papers, routine and directed patrol, traffic and DUI enforcement. In addition, the department is staffed with personnel possessing specialized training in search and rescue, special weapons and tactics (SWAT), and other special operations and emergency response. This Division has five sergeants, fifteen deputies and three animal control officers. The CID section is tasked with the detailed and extensive follow-ups that are necessary with serious crimes such as homicides, sexual assaults, grand larcenies and narcotics. The CID unit is made up of one sergeant and three investigators.

The Communications Division, lead by 911 Operations Manager Melissa McDaniel, provides critical communication and emergency dispatch to all first responders. The communication center is setup with four consoles and is staffed 24 hours a day, 365 days a year to serve the citizens of the community. Communications has fourteen communication officers, including three training officers.

Steve Keene serves as Program Manager of the **Planning and Programs Division**, which conducts research, plans, develops and implements innovative approaches to complex criminal justice, public safety and emergency preparedness issues. And finally, the **Victim/Witness Assistance** Director is Pam Perrier, who assures that every possible benefit, service, and courtesy be extended to crime victims and witnesses.

In Memory:

Deputy Rodney Lee Davis was appointed a deputy by the Greene County Sheriff William L. Morris on April 1, 2001. He had also been a Deputy for the Newport News Sheriff's Office for 5 years prior and the Middle Peninsula Regional Jail for over years prior to that. In the early morning hours of August 26, 2003, Davis was assisting another deputy with a warrant where Davis was outside perimeter when gunshots began to be heard from inside the home of the suspect. Davis headed into the home to assist the other deputy and was met with gunfire from the suspect as they met in the kitchen area. Davis lost his life due to this gun battle, as did the suspect. The other deputy survived the incident with no major injuries. Rodney Lee Davis, an Illinois native, was 30 years old when he died. He was the first deputy of the Greene County Sheriff's Office to die in the line of duty.

Deputy Chadwick Alan Carr was appointed a deputy by the Greene County Sheriff J. Scott Haas on March 24, 2008. He had also been a deputy for the Orange County Sheriff's Office for 6 years prior. About 1:30 p.m. on June 4, 2009, Carr was headed to assist with an undercover narcotics buy, as he was assigned as Greene County's narcotics investigator. Carr was going north on Madison Road and went off the right side of the roadway. Carr's vehicle then came back across both lanes of travel being struck by a tractor trailer headed south on the same roadway, both vehicles burst into flames immediately. Carr lost his life due to this accident. Chadwick Alan Carr, a Northumberland County native, was 31 years old when he died. Carr is the second deputy of the Greene County Sheriff's Office to die in the line of duty.

Deputy Randal Howell passed away September 14th, 2011. He served Greene County Sheriff's Office from June 2004 until June 2008, resigning at the rank of Corporal so that he could return to his native state of West Virginia for a job closer to home.

Major Russell Lane past away January 2, 2013 from a long battle with cancer. He served in Greene County from January 2012 to his death, and served with the Culpeper Police Department and the Culpeper Sheriff's Office prior to coming to Greene County.

Darrel Lawson died at the age of 61as a result of natural causes. He served as emergency services dispatcher before becoming animal control officer, where he served for many years.

Planning and Programs Division:



The Planning and Programs Division is responsible for researching, developing, implementing, and evaluating innovative approaches to complex criminal justice, public safety and emergency preparedness issues. The Greene County Sheriff's Office ranks among the highest in the state for the amount of community and safety programs offered to citizens. The following programs are at work in Greene County. Steve Keene and Michael Martin were tasked with leading this unit once Sheriff Smith took office in 2012.

Internet Safety



Internet Crimes Against Children (ICAC)

The ICAC Task Force was created to help federal, state and local law enforcement agencies enhance their investigative responses to offenders who use the Internet, online communication systems, or computer technology to sexually exploit children. The super computer "Cop-in-a-Box" has the capability of interdicting criminal activities associated with online predators targeting our children and teens.





Offender-Work Program



Non-violent offenders perform community service in a variety of ways. "Work-teams" and "trustees" are utilized from the Central Virginia Regional Jail, and both juveniles and adults complete community service assignments, such as litter pickup, imposed by the court system. In 2013 over 35 offenders participated in our community service programs totaling over 1,500 hours of service and restitution. To date over 85 offenders have participated and over 3,500 hours of service and restitution.

Various organizations have donated to enhance programs







Assign-A-Highway utilizes probationers assigned to pick up litter along the roads. The assignments are written into court documents as conditions of the probation. The program differs from Adopt-A-Highway in which volunteers, such as members of civic groups, willingly volunteer to keep a two-mile section of highway clean. Probationers are picking up litter as part of their punishment. This is a collaborative effort from the Commonwealth's Attorney, Probation and Parole, and the Sheriff's Office. Over 10 probationers have worked over 700 hours and have picked-up over 12 tons of trash along Greene County roads in 2013. For 2012 and 2013, over 25 probationers have worked over 1,700 hours, and have picked up over 34 tons of trash in Greene County.

Citizens Corps

Greene County Sheriff's Office has been actively participating in Citizens Corps, which involves Community Emergency Response Team (CERT), USA On Watch, and Volunteers In Police Services (VIPS). They provide vital services to our community, as resources continue to dwindle and demands for services continually increase. Our Citizens Corps volunteers have contributed to the following:

Volunteers in Police Service (VIPS)



Volunteer activities make communities safer, stronger, and better prepared to respond to any emergency situation. It provides opportunities for people to participate in a range of measures to make their families, their homes, and their communities safer from threats of crime, terrorism, and disasters of all kinds. In 2013 there were 6 VIPS volunteers in Greene County.

Community Emergency Response Team (CERT)



Trained CERT members fill a vital role in the moments immediately following an emergency before first responders arrive on scene. Training involves basic disaster preparedness, such as fire safety, light search and rescue, team organization, triage and first aid, disaster psychology and terrorism awareness. CERT members also support emergency response agencies by taking a more active role in emergency preparedness projects in their community, both in spreading the word about preparedness and in assisting agencies during response operations. In 2013 Greene County graduated its first ever CERT class of 43 citizens, where 28 of them currently serve on the GCCERT volunteering in an array of activities and services, documenting more than 2,500 hours, valued at \$24 per hour.



Neighborhood Watch




Neighborhood Watch is undoubtedly one of the oldest and most well known crime prevention concepts in history. Its roots in America can be traced all the way back to the Colonial days when night watchmen patrolled the streets. Monthly watch meetings are taking place, with approximately twenty-five citizens actively participating in strengthening this program. This program has received over 200 hours of service by volunteers in 2013, and over 500 hour total for 2012 and 2013.

Refuse To Be A Victim Seminars



Through the Refuse To Be A Victim seminar, citizens learn personal safety tips and techniques to avoid dangerous situations and avoid becoming a victim. Hundreds of federal, state, and local law enforcement officials across the country have implemented Refuse To Be A Victim into their crime prevention and community policing initiatives. Over 30 citizens took part in this seminar in 2013. Over 100 people for total for 2012 and 2013.

Eddie Eagle GunSafe Program for Kids





Eddie Eagle teaches children in pre-K through third grade four important steps to take if they find a gun, in an easy-to-remember format consisting of the following simple rules: *If you see a gun: STOP! Don't Touch. Leave the Area. Tell an Adult.* Over 40 children have benefited from this program in 2013, and over 90 total for 2012 and 2013.

Supporting other Stakeholders!

The Greene County Sheriff's Office fully supports and promotes local and regional programs that focus on youth outreach, crime reduction, increasing rehabilitation efforts, assuring appropriate punishment, job placement, and "reentry" initiatives involving offenders returning to society. The Public Safety Foundation of Greene County is a non-profit 501-C3 formed in response to safety concerns of a rapidly growing County. The mission of the Foundation is to work in partnership with the Sheriff's Office, the Courts, Corrections, and other community groups to help fund programs that will enhance public safety and community well-being for all in Greene County. For identified programs the Foundation raises the needed funds through private donations and grants.



Citizen Criminal Justice Academy





During spring and fall 2013, local citizens 18 and older participated in the Greene County Citizen Criminal Justice Academy. This 10-week program introduces residents to the three components of criminal justice – law enforcement, court process and corrections. This year, approximately 40 citizens graduated from our academies. To date, over 80 have graduated.

Junior Academy

In 2013 over 17 teens graduated from a 1-week curriculum, concentrating on drug awareness, first aid, CPR and AED, driver safety, firearm safety, search and rescue and swimming. To date, over 36 teens have graduated.

Youth Outreach and Faith-Based Support

The Greene County Sheriff's Office fully supports and promotes local and regional programs that focus on youth outreach, crime reduction, increasing rehabilitation efforts, assuring appropriate punishment, job placement, and "reentry" initiatives involving offenders returning to society. GCSO is currently supporting and promoting Restorative Justice and Reentry efforts in Greene County, affecting more than 100 offenders showing promise of not re-offending, gaining meaningful employment and participating in other programs while paying restitution.





Student Internship Program



The Greene County Sheriff's Office is dedicated to supporting surrounding students as they pursue careers in the criminal justice field. Interns provide useful human services as they obtain course credits to complete their educational groundwork and gain valuable first-hand experience. This year 1 student participated in our program, and to date, 4 interns have completed our program from Longwood College, Sweet Briar College and James Madison University.

The **Virginia Sheriffs' Scholarship Program** was established to provide an opportunity for young people across Virginia to pursue an education in criminal justice. In 2013 one Greene County citizen benefited from the award to further his education in the justice and safety field.

Ride-Along Program

Citizens are encouraged to participate in our Ride-Along program to get a first-hand experience of what law enforcement work is all about. Over 15 people participated this year, and over 35 for 2012 and 2013 combined.

Firearms Safety



Greene County Sheriff's Office is proud to be one of the first in the state to offer citizens free firearm safety and concealed-carry classes, concentrating on safety, fundamentals, safe storage, legal transport, reciprocity, firearm statutes and self-defense case law. In 2013 GCSO provided over 60 classes to over450 citizens. To date, over 110 classes have been give to over 1,050 citizens.

Hunter Safety



Hunter's education classes are designed to teach juveniles over the age of 12 safety and sportsmanship. The main goal of the class is to teach firearm safety, but it also teaches about ethics, wildlife conservation, archery, muzzle loading, survival, tree stand safety, hunting laws and first aid. Greene County Sheriff's Office offers this class twice per year.

Project Lifesaver

This program bridges the gap for "at risk" populations and public safety agencies. It provides first responders with a comprehensive program including equipment and training to quickly locate and rescue individuals with cognitive disorders who are at constant risk to the life threatening behavior including those with Alzheimer disease, Autism, and Down syndrome.



Objectives of Crime S toppers

Crime Stoppers objectives are to raise reward funds to be awarded to community members who assist in the apprehension and conviction of criminals. In order to carry out this objective, Crime Stoppers is funded from members of the public, including individuals, corporations, clubs, associations and other organizations. When appropriate, Crime Stoppers may also receive funding in the form of money, goods or services from Federal, State, and local governments as long as the receipt of such funds does not violate any law or cause Crime Stoppers to lose its tax exempt status under the regulations of the United States Internal Revenue in effect. Crime Stoppers also has a fund raising committee to organize an event on a yearly basis to help with the reward funds. All rewards that are paid out for the apprehension and or conviction are anonymous. A check is written to the detective working the case who pays the individual in cash.

Accomplishments

Some of the accomplishments of Crime Stoppers since January 2002, Crime Stoppers have paid out a total of \$22,295.00 for 90 regular cash rewards. The largest was \$1000.00 (maximum permitted by the bylaws without a specific executive committee approval); the smallest was \$25.00 with average being \$250.00. Several years ago, one of the payouts was for the resolution of murder of a young woman in the City of Charlottesville. In addition to the regular awards, Crime Stoppers has paid awards for two (2) especially serious crimes. In 2008, Crime Stoppers paid out \$60,000.00 for the conviction of a serial rapist case which occurred in numerous locations. In 2009, Crime Stoppers paid out a total of \$6000.00 for the conviction of the perpetrators of the Wood Grill robbery/murder. Both of these rewards paid by Crime Stoppers were from dedicated contributions. Crime Stoppers is currently holding dedicated funds for five (5) cases, including two (2) missing persons case. The largest of the dedicated funds Crime Stoppers holds is \$150,000.00 which is being held for the resolution of the Morgan Harrington abduction and murder case.

Annual Golf Tournament

The annual golf tournament at Greene Hills Club raises money for our annual Christmas giving program for underprivileged children. Each year over 50 children get to go Christmas shopping at Wal-Mart as a result of proceeds from the golf tournament, which would otherwise not have the opportunity for presents.





Prescription Drug Disposal



In 2013, Greene County was the first sheriff's office in the state to initiate a safe and convenient means of disposing of unwanted and outdated prescription drugs.

Chaplains



We are fortunate to have two GCSO Chaplains who volunteer spiritual guidance and counseling services.

Auxiliary/Reserve Program

In 2013 GCSO revitalized the auxiliary deputy program and in 2014 expect to graduate several reserves that will volunteer their time to augment enforcement and various programs. The reservists will be equipped by the Public Safety Foundation of Greene County.



Child ID Program



In 2013, more than 500 Greene County children obtained identification cards to be used in emergency situations where vital information can be presented quickly and accurately. This year volunteers worked over 450 hours assisting with this program. To date, more than 1,000 children have obtained ID's and volunteers have contributed over 950 hours.

School Safety

School Crisis and Training – In 2013 Greene County CERT and the Public Safety Foundation of Greene County collaborated to provide schools with crisis boxes, with more kits and training for staff in 2014. Over 150 volunteer hours have been dedicated to this initiative in 2013, and over 300 hour total for 2012 and 2013. In addition, staff continuously attended trainings and exercises dedicated to enhancing school safety measures.



Triad



TRIAD is a cooperative effort of law enforcement agencies, senior citizens, and senior organizations, focused on reducing crimes against our seniors. Monthly meeting of Triad occur in Greene County at the Jefferson-Madison Regional Library, where over 20 seniors participate in various programs, such as: home safety, safe shopping, fraud and scam awareness, victim/witness, medicare, fraud awareness available county law enforcement services, and education, awareness and preparedness seminars.

Community Education, Awareness and Preparedness Training

Community Preparedness Training – Several CERT members have obtained professional First Aid, CPR and AED training and have shared this and other measures with the public. Over 300 volunteer hours. In 2013, volunteers saved Greene County tax payers over \$33,000 based on the value placed on volunteer efforts by the state. For 2012 and 2013 volunteer efforts has exceeded \$58,000.



Security Assessments

Our crime prevention specialist officer, along with others, assists citizens with assessing vulnerabilities to their homes and businesses.

Communication Division:



The Greene County Emergency Communications Center serves as the Public Safety Answering Point (PSAP) for Greene County twenty-four (24) hours a day, seven (7) days a week. We operate a three (3) channel, VHF conventional (analog and digital system), PL steered radio system, a Computer Aided Dispatch system, a Master Street Addressing Guide system, regional interoperability equipment and an enhanced 911 system. Our staff currently consists of ten full time employees and two part time employees that are professionally trained and constantly strive to protect and serve individuals during emergency and non-emergency situations.

As the PSAP for Greene County, we are responsible for all 911 calls; this includes wireline, wireless, and voice over internet protocol calls that originate within our borders. All requests for service are handled in a timely manner and dispatched according to protocol.

Our staff receives extensive training in radio procedures, emergency call-taking and standard operating procedures for all agencies for which services are provided. In addition, they must become certified with the Department of Criminal Justice and the Commonwealth of Virginia by attending a six day academy provided by the Central Shenandoah Criminal Justice Academy. At a minimum, staff must also be certified in the following courses:

Code Red

Code Red is a communications system in place that allows citizens to register to be notified by phone of impending emergencies and/or reverse 911 where dispatch can contact the citizenry.

OUR MISSION!

The Greene County Emergency Communications Center is a dedicated team of communications professionals who provide the critical link between public safety responders and the community we serve.

Field Operations Division:



The patrol division of the Greene County Sheriff's Office consists of 8 Deputies, 4 Sergeants and a Lieutenant. The division is the most visible unit in the Sheriff's Office, operating 24 hours a day, 7 days a week, 365 days a year. Deputies patrol approximately 156 square miles. This division of the Greene County Sheriff's Office is responsible for crime prevention, preliminary investigations of most crimes and complete investigations of others, preparation of reports relating to crimes or incidents, traffic enforcement, and non-crime related services. The patrol division is also responsible for the process and execution of various criminal warrants along with civil paper service. A Deputy Sheriff within the patrol division is often the first contact many have with the Sheriff's Office. The Greene County Sheriff's Office strives to make all contacts with the community we serve be as professional, courteous, and compassionate and objectively fair as possible. The patrol division is commanded by a Lieutenant who reports to the Captain. Units within this division are: patrol, school resource officer, motor carrier, SWAT, advanced civil process, bicycle and animal control.

School Resource Officer Program

The Greene County Sheriff's Office, presently has 3 full time personnel assigned to the SRO positions, present whenever students are at school, to include after school events and sporting activities. Greene County Schools presently have a student population of over 3,000 students, with 6 school buildings, on 3 different sites. SRO's are primarily assigned to William Monroe High School and William Monroe Middle School, with shared time between the elementary schools and technical education center. Candidates for School Resource Officer are chosen on a voluntary basis from active agency members in good standing. Additional candidates for the SRO position must:

- 1. Have an interest in working with the youth
- 2. Demonstrate an ability to work with diverse groups
- 3. Demonstrate conflict-resolution skills
- 4. Demonstrate knowledge of juvenile law, procedures and appropriate community resources
- 5. Demonstrate a positive role model for the citizens of Greene County
- 6. Have at least two years of experience in patrol duties

Court Services



Personnel assigned to court services consist of two deputies and one sergeant, and they perform a variety of functions, including courtroom security, the transportation of convicted inmates and pre-trial detainees to and from court, the intake and processing of defendants remanded to custody, and the screening of persons and parcels entering the courthouse.

Civil Process

The Greene County Sheriff's Office Civil Process Unit is responsible for the serving court papers issued from all Virginia State courts and those processed and issued by other states, being served in the County of Greene. Civil Process is tasked with executing warrants, evictions, repossessions, levies, sheriff sales, extraditions, and providing assistance to the Patrol Deputies when necessary. This unit is charged with the delivery of processes in a timely efficient manner. (See stats on civil process below).

K-9 Patrol

Bicycle Patrol

The Bicycle Patrol Unit within the Field Operations Division has two bikes with certified officers to ride during community events, which promotes community policing and increases officer/citizen personal contact.



Animal Control

Ensures agency compliance with all applicable codes, laws, rules, regulations, standards, policies and procedures; ensures adherence to established safety procedures; monitors work environment and use of safety equipment to ensure safety of employees, citizens, and other individuals; initiates any actions necessary to correct deviations or violations.

Enforces the provisions of all applicable animal control ordinances, codes, laws, and regulations; initiates any actions necessary to correct deviations or violations; issues warning notices or citations as appropriate.

Consults with the Lieutenant and other officials to review operations/activities, review/resolve problems, receive advice/direction, and provide recommendations; coordinates work activities with those of other departments, health department officials, veterinarians, outside agencies, or others as needed.

Develops and implements long and short term plans, goals, and objectives for the area of assignment; evaluates efficiency and effectiveness of operations, programs, procedures, and resource management; recommends and/or implements improvements as needed.

Develops, updates, and enforces policies and procedures for area of assignment.



Victim/Witness Unit

This program functions Monday- Friday every week and on weekends or nights as required providing prompt attention to the needs of victims. Once a law enforcement officer creates a report for an incident, the report goes to the records department. The records department notifies this program of all reports. The director reads all reports and determines if there is a victim in need of services. Victims are contacted either through mail or by phone and are advised of their rights and the services available. Once it is determined what services the particular victim require; the program attempts to meet those needs as availability allows.

In 2013 the Victim/ Witness program assisted 331 victims. Of those, 45 were domestic violence victims, 73 victims of assault, and 76 victims of property crimes.

Greene County sponsors several advanced trainings each year.
