

Greene County Sheriff's Office RIDE ALONG WAIVER

AGREEMENT ASSUMING RISK OF INJURY OR DAMAGE WAIVER AND RELEASE OF CLAIMS, AND INDEMNITY

Whereas I, ______, being / not being over the age of twenty-one (21), but over the age of eighteen (18) and not being a member of the Greene County Sheriffs Office have made a voluntary request to ride as a guest in a vehicle assigned to the Sheriff's Office and to accompany a member or members of the Sheriff's Office during the performance of their official duties.

Whereas, the Greene County Sheriffs Office is willing to allow me to ride as a guest in a vehicle assigned to that office and to accompany a member or members of the Greene County Sheriffs Office during the performance of their duties on the following conditions.

Now, therefore, in consideration of the permission given to me to ride in a vehicle assigned to the Greene County Sheriffs Office and to accompany a member or members of said Sheriff's Office during the performance of their official duties, I do hereby agree:

- 1) That I am aware that the work of the Greene County Sheriffs Office is inherently dangerous and that I may be subjected to the risk of death or personal injury or damage to my property by accompanying a member or members of the Sheriff's Office during the performance of their official duties and that I freely, voluntarily and with such knowledge assume the risk of death, personal injury, or property damage, arising from or in any way connected with the use of weapons, unlawful acts, or forcible resistance by law violators or suspected law violators, assault, riot, breach of the peace, fire, explosion, gas, electrocution, or escape of radioactive substances while accompanying a member or members of the Sheriff's Office during the performance of their official duties.
- 2) That the County of Greene, Sheriff of the County of Greene, his sureties, all members of the Greene County Sheriffs Office and their sureties, and each of them, shall not be responsible or liable for any injury, damage, loss, or expense, either to me or to my property, incurred riding in any vehicle assigned to the Greene County Sheriffs Office while accompanying any member or members of said Sheriff's Office during the performance of their official duties and resulting from any negligent act or omission on the part of any member of the Greene County Sheriffs Office.
- 3) For myself, my heirs, executors, administrators, and assigns to defend and indemnify the County of Greene, Sheriff of Greene County, all members of the Greene County Sheriffs Office, their sureties and each of them, against any and all manner of actions, causes of actions, suits, debts, claims, demands, or damages or liability or expense of every kind and nature incurred or arising by reason of any actual or claimed negligent or wrongful act or omission of mine while riding in any vehicle assigned to the Greene County Sheriffs Office or while accompanying any members of said Sheriff's Office during the performance of their official duties.

I hereby represent that I have carefully read and understand the contents of this document and sign the same of my own free will.
